

## 2010 Blue Ribbon Ride/Owens House Sponsors

The Blue Ribbon Ride is an annual open motorcycle ride in support of the Shelby County Children's Advocacy Center (SCCAC), Owens House, with the goal of building awareness of child abuse and raising funds for SCCAC.
